RE: **Charles River Dam - Deliberation Process Overview**

Introduction

This memorandum is provided to outline the proposed community engagement process Town Administration recommends to follow in the coming year with regards to the aging Charles River Dam (“Dam”) in South Natick. Owned and maintained by the Town, the Dam is permitted through the Commonwealth’s Department of Conservation and Recreation (DCR) with required inspections once every two years. DCR has classified the Dam as a high hazard dam. Further, the most recent inspection completed by the Town identified some deficiencies in the Dam that will need addressing in the coming years, requiring significant investment to either replace or remove the Dam.

While the decision on how to proceed will ultimately rest with the Natick Select Board, with funding voted on by Town Meeting, Town Administration is intent on ensuring there is broad consultation and deep deliberation within the community to help inform the decision(s) the Town must make to addressing the deficiencies with the Dam. In order to make a thoughtful decision that incorporates the wisdom of the community, as well as the expertise of various Town departments, Town Administration created an internal planning team of employees (copied on this memorandum noted above). This team has sought advice from other colleagues within the Town government, including local elected officials, and has engaged with Ona Ferguson, Senior Mediator at the Consensus Building Institute, to help inform a robust community engagement strategy for this initiative.

Based on the work of this team, Town Administration proposes the creation of an “Advisory Committee,” which will be responsible for evaluating the options on what to do with the Dam and presenting its recommendation to the Select Board. The evaluation process will include not only hearing from consultants on the various options for the Dam, but also completing a comprehensive community-wide engagement effort, as described below.

Proposed Role and Structure of Charles River Dam Advisory Committee

Purpose

The Advisory Committee will work together in a series of meetings to review the options for the Charles River Dam in South Natick and develop a recommendation to the Select Board on what the Town should do with the Dam. While the group will aim for a consensus recommendation, if such a consensus recommendation cannot be reached, the Committee will capture the major elements of the discussion and identify where there is greater and/or lesser agreement and why.

Proposed Composition

General participation on an Advisory Committee that would work to develop a recommendation seeks to include broad representation from both Town government as well as key stakeholders. All members are proposed as full participants, seeking to reach broad consensus on a recommendation. The Committee is proposed to be appointed by the Town Administrator and include a group of up to 15 participants with diverse areas of expertise and focus. The Committee is expected to invite content experts as needed for particular discussions. Town Administration seeks to keep leadership in the neighboring municipalities of Dover, Wellesley and Sherborn apprised of this process.
